


Dear Sierra Lakes County Water Resources Board of Directors,

Our family has owned a small cabin at 4192 Donner Dr. for 50 years. It is a modest cabin and consequently we use a small amount of water and sewage services. I do not understand why there is a standard charge for water and sewer services at Serene Lakes. Certainly full-time residents and multi-million dollar mega-mansions with multiple bathrooms and hot tubs use much more water and resources than does my family.

I believe that water charges should reflect usage and/or size of building rather than one standard charge for all, irrespective of size, value, and water and sewage usage of the building.

Please consider adjusting charges for water so that they are equitable, particularly for those like my family who have chosen to live responsibly and conserve our limited precious resources. In this age of global climate crises, public policy should encourage conservation of our water resources rather than penalizing those who live modestly in order to subsidize extravagant resource usage by those who build enormous cabins and use disproportionate quantities of natural resources.




